Background:

We, the Board Members of the Rice Economic Development Corporation (EDC), are happy to announce our decision to grant a new Cool-Space 500 portable, evaporative cooler to the City of Rice Parks & Recreation Department to be used in the City of Rice Gym*. We believe that this donation will significantly enhance the experience of those who use the gym for sporting and community events.

We want to recognize the efforts of the City of Rice and citizen volunteers to make better use of our recreational facilities, and hope to contribute to this ongoing endeavor by helping to create a more enjoyable environment. The Cool-Space 500 will cool up to 6,500 sq/ft by 33°F for 10 hours without needing to be connected to a hose (once the reservoir is full). We believe that it will be a valuable addition to the department's resources, ensuring that patrons of the City of Rice Gym can stay comfortable during their use of the facility.

We also want to comply with our mission as an EDC to create additional revenue. Our intent is for the Cool-Space 500 to be used as a resource to increase gym rentals, and as an option to collect additional fees.

We are excited about this contribution and look forward to working closely with the City of Rice to ensure its successful implementation. We are honored to be able to assist with the continued improvement of our city's Parks and Recreational facilities, and creating more accessibility for all to enjoy them.

Proposal of EDC Projects: 2024

Parks & Recreation Improvements*: Our goal is to create a climate controlled environment for our City of Rice Gym, and the batting cages at Mike Dickens Memorial Park. This will make our recreational spaces more for sporting and other event rentals; and also make the gym safer and more comfortable for the community,

- We will use budget money to purchase an 18' Fan for the Gym, and an additional portable evaporative cooler to be used in the batting cages at Mike Dickens Memorial Park.
- We will pursue grant money to install air conditioning, and other climate control updates, and general improvements to the City of Rice Gym.

Improvement of Downtown Property*: Our goal is to create a safer and more attractive area for our downtown area for our residents and visitors.

- **Phase 1:** We will use budget money to add lights (donated) and 5 50 AMP electric hookups. These improvements will not only create a safer enviroment, but will make it a more attractive location for vendors and events.
- **Phase 2:** We will pursue grant money as part of our larger plan to include shaded coverings, walkways, an entrance, etc.

Advertising: Our goal is to help draw attention to Rice as a viable location for new businesses and as a destination for visitors to our businesses and events.

- We will use budget money to purchase online ads and/or publication ads featuring Rice businesses, City of Rice events, and to generally promote the viability of our city.
- We will pursue free opportunities in local newspacers, and on social media for additional exposure

Business Grant*: Our goal will be to increase local sales by growing existing businesses, and attracting new business - resulting in more sales tax revenue. Our application process will require that applicants have a comprehensive plan for growth, and establish their financial requirements. It will include a scoring process and a structured follow-up process, to ensure accountability.

- We will use budget money to grant qualified applicants funding to suit their proposed plan (up to \$30,000).
- We will offer free resources to businesses who need help developing their business plan.

Shipping and handling is an estimate.

Our proposals include an estimate of applicable itemized sales taxes which Big Ass Fans is legally obligated to collect and remit. The final, actual amount of such taxes would only be known at the time the customer is actually invoiced for the order.

The Buyer must insure that product specifications are consistent with actual field installation requirements. Big Ass Fans product recommendations are based on product specifications as transmitted to the company. As such, Big Ass Fans is not responsible for inaccuracies between the communicated product specifications and actual field installation requirements. The Buyer of the specified products assumes responsibility for the cost of returning or exchanging specified product where specified product does not meet field requirements.

Any variations to product types or quantities (or omissions of existing light fixtures during the survey process – and now not represented in project) will be considered "add-on" and an additional material requirement. These add-on materials will be priced separately.

Big Ass Fans customers who have been approved for term credit and are invoiced for their orders may pay their invoice through one of our customary term credit payment methods of: Check, money order, wire transfer or ACH payment. Any such term credit approved customers who subsequently elect to pay their term invoice by credit card will also be charged a convenience fee for doing so. The exact amount of the convenience fee will be communicated to the customer before the transaction is processed and the card is charged. Buyer covenants and agrees to promptly pay any such amounts to Big Ass Fans on the same terms and conditions as any other amounts owed to Big Ass Fans on the applicable Order.

The transaction and contract that is the subject of this Proposal shall be governed by the internal laws of the Commonwealth of Kentucky. Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.

Upon sales agreement being signed and submitted, order shipment date changes may not be submitted or changed by the purchasing party within 10 business days of scheduled shipment. The Rice EDC is focused on attracting and strengthening local businesses, and encouraging job creation to encourage economic development for the City of Rice. Our business grant program is designed with those goals in mind.
